<u>Serials and Subscriptions and Supplies Contracts:</u> We are currently mid-cycle of the one year renewal for the Supplies and Serials contracts. The RFP process will start in the Spring of 2015 beginning with a member evaluation survey of services in early March.

<u>Gaylord Brothers:</u> Effective Jan. 1, 2015, Gaylord Brothers will no longer be selling library supplies or furniture. Their contract will be terminated as of that date at their request.

<u>Non-Contracted Vendors:</u> Children's Plus, Inc. contacted me requesting to be considered a non-contracted vendor. I sent an email to the listserv containing their services, discount and contact information. This information is also listed on our website under the Non-Contracted Vendors link.

<u>Gale/Cengage Revision:</u> The summary information for Gale/Cengage has been revised from "free shipping" to "free shipping on prepaid orders and orders over \$500.00" to more accurately reflect the terms outlined in their contract.
